SPEND CATEGORY	LEGACY OBJECT CODE
Book Royalties (SC0094)	6300 <u>Royalties - Books</u> : Royalty payments to authors or their designees for books published by the LSU Press or other University departments.
Patents (SC0095) Royalty Payments (SC0350)	6320 <u>Royalties - Patents</u> : Royalty payments to inventors for patents owned by the University.
Licensing Fees (SC0096)	6400 <u>Licensing Fees</u> : Fees paid for the use of copyrighted music or musical/ dramatic productions; fees for the rights to use and/or reproduce copyrighted written or audio/visual materials; or other similar fees paid.
Cash Over/Short (SC0098)	6520 <u>Cash Over or Short</u> : Used to record cash overages and shortages in activities having cash operations.
Housing Allowances (SC0099)	6530 <u>Housing Allowances</u> : Housing allowances approved by the Board of Supervisors for housing of certain employees.
Dependency Allowances (SC0100)	6531 <u>Dependency Allowances</u> : Federal grant payments to sponsored students for dependents.
Training Fees and Registrations (SC0101)	6550 <u>Fees and Registrations</u> : Student fees and registrations paid by LSU for specialized training, including both amounts paid to other schools and tuition and fee rebates paid to employees for courses taken at LSU.
Matching - NDEA and NDSL (SC0102)	6560 <u>Matching - NDEA & NDSL</u> : Matching of federal funds for student loans.
Official Functions - Entertainment (SC0103)	6580 <u>Official Functions - Entertainment</u> : Cost of entertaining by LSU employees of other individuals or groups at official functions. Such expenditures cannot be charged to restricted state or federal grants and contracts or to restricted private grants and contracts involving state or federal pass through funds.

Athletics - Special Meals - Recruiting (SC0104)	6581 <u>Recruiting Functions – Special Meals</u> : Cost of meals associated with recruiting functions.
Official Functions - Business Meeting Meals (SC0105)	6585 <u>Office Functions - Business Meeting Meals</u> : Cost of meals associated with a business meeting that is predominantly for the dissemination of scientific, technical, or administrative information.
Premiums, Prizes and Awards - Cash (SC0106)	6590 <u>Cash Premiums, Prizes and Awards</u> : Cash awards in University-sponsored activities (such as rodeos, horse shows, etc.) and other cash awards. (Use object 6640 for payments to students for academic excellence or financial need.)
Awards/Trophies (SC0303) Certificates (SC0304) Plaques (SC0305) Premiums, Prizes and Awards - Non-Cash (SC0113)	6670 <u>Non-Cash Premiums, Prizes, and Awards</u> : Non-Cash awards, such as blue ribbons, trophies, plaques, etc.
Property Assessments and Tax (SC0107)	6600 <u>Property Assessments & Taxes</u> : Payments for paving, sewerage, etc., improvements of University-owned properties.
Property Losses/Uninsured (SC0108)	6610 <u>Property Losses - Uninsured</u> : Portion of casualty losses not covered by insurance.
Registration Fees/Local (SC0109)	6620 <u>Registration Fees - Local</u> : Payments of registration fees for conferences, seminars or training where no travel is involved.
LSU Non-Credit Registration Fees (SC0110)	6625 <u>LSU Non-Credit Courses Registration Fees</u> : Registration fees for Continuing Education's non-credit courses.
Athletic Guarantees (SC0115)	6690 <u>Athletic Guarantees</u> : This is the money paid to an agency or group guaranteeing proceeds for an athletic event.

Auxiliary Surcharge (SC0116)	6720 <u>Auxiliary Indirect Charge Surcharge</u> : Overhead costs charged to auxiliary enterprise operations.
Facilities and Administration - Expired Fixed Price Balances (SC0117)	6750 <u>Expired Fixed Price Balances</u> : For use by Sponsored Program Accounting only.
Gift - Administrative Fee (SC0344)	6760 <u>Administrative Fee on Gifts</u>
Federal Income Taxes (SC0121)	6940 <u>Federal Income Tax Expense</u> : Payments of Unrelated Business Income Taxes (UBIT) resulting from unrelated business activities of the University.
Other Charges/Miscellaneous (SC0122)	6960 <u>Other Charges - Miscellaneous</u> : Expenditures that are not appropriately charged to other categories and that cannot be classified into specific objects under <u>Other Charges</u> .
Health Plan Expense - Claims (SC0123)	6965 <u>LSU First Claims Payments</u> : Payment of medical claims for participants enrolled in the LSU System LSU First Health Plan. (This object code is for System use only.)
Health Plan Expense - Administration Fees (SC0124)	6967 <u>LSU First Administrative Fee</u> : Fees paid to third party administration of the LSU System LSU First Health Plan. (This object code is for System use only.)
Health Plan Expense - Plan Administration Fees (SC0125)	6969 <u>LSU First System Administrative Fee</u> : Fees paid to the LSU System for administration of the LSU System LSU First Health Plan. (This object code is for System use only.)
