 Veterans and service members are eligible for one credit hour for every four months of active duty, with a maximum of 12 credit hours for four years of active duty. Military transcripts are evaluated for each applicant, and additional credit may be awarded. This credit will be awarded on a case-by-case basis for lower-level courses. All upper-level courses are accepted, excluding duplicates.  
 Current and former service members can send military transcripts through the Joint Service Transcript System. Once logged in, select Transcripts, then Official Transcript Request. Search for "Louisiana State," and select online delivery to Louisiana State University-Baton Rouge.
