Re: Biannual Report on Power-Based Violence

Date: April 24, 2022`

Act 472 of the 2021 Regular Legislative Session of the Louisiana Legislature outlines a biannual reporting requirement for institutions of higher education detailing incidents of power-based violence reported on their campuses. This reporting requirement ensures that every level of leadership between the campus and the Legislature has an opportunity to see and respond to the data. The reporting deadlines for the April cycle are as follows:

April 10	Report transmitted from Title IX Coordinator to Chancellor
April 24	Report transmitted from Chancellor to President
May 8	Report transmitted from President to Board of Supervisors
May 22	Report transmitted from Board of Supervisors to Board of Regents
June 6	Report transmitted from Board of Regents to Louisiana Legislature

The Board of Regents created and published in the Uniform Policy on Power-Based Violence a spreadsheet and forms to be used for reporting these data. This report, including the spreadsheet, is being submitted to you as the **second step** in this reporting structure. In a measure of accountability and transparency and as required, this report will be placed on our website, <u>www.lsu.edu/titleix-review</u>.

The attached Form B2 provides data on Confidential Advisors and Responsible Employees.

• Number of Employees was gathered from a Workday report run on 4/1/2022 and includes employees in Faculty, Staff, and Graduate Assistant positions, minus the number of Confidential Advisors.

• Number of Confidential Advisors is reflective of best practices recommended by the Board of Regents which is one Confidential Advisor to 1,500 students. The 14th class day enrollment of Full-Time, Part-Time, Graduate, Undergraduate, Professional, and Online students for Fall 2021 published by the Office of Budget & Planning is 35,914. We have 24 faculty and staff who have been trained according to Board of Regents standards which meets the 1:1,500 ratio. The names of these 24 employees can be found at https://www.lsu.edu/support/talk-to-someone.php.

• Annual Training is defined as the number of employees who completed the annual training on Power-based Violence prepared by the Board of Regents. The production of this training in a format that was useful and trackable by the campuses was more

challenging than expected, but thanks to dedicated work by the Board of Regents staff and then by our campus HRM, ITS, and Title IX groups, the online training modules were launched on April 19, 2022. Responsible employees should complete this by September 30, 2022 in order to report these numbers in the October reporting cycle.

• Our Confidential Advisors have not had access to the annual training due to the complications of getting it into the system. However, all Confidential Advisors completed the Board of Regents required training last fall, and all attended a three-hour campus sponsored professional development opportunity with STAR in January on trauma informed practices.

• We had no instances of False Reports nor instances of reported Retaliation.

• As provided on the accompanying spreadsheet, there were nine Formal Complaints filed between October 1, 2021 and March 31, 2022. Six are open in the investigation phase, two were closed through Informal Resolution, and one was closed because the complaint was withdrawn.

ADDENDUM

The following information is offered to give more specificity and perspective to the actions taken by the Office of Civil Rights & Title IX over the past six months. In ongoing self-reflection, we will use the information below as we develop workshops and training sessions in future semesters for students and employees.

Type of Case

Of the 182 reports received by the Title IX Coordinator and included on Tab 1 in the spreadsheet, 108 (59%) were considered Title IX complaints and 74 (41%) were considered Power-Based Violence complaints. Those labeled as Power-Based Violence complaints are ones we know are not under the jurisdiction of Title IX.

Of the 182 reports received by the Title IX Coordinator during this time period, 165 (91%) were closed without any disciplinary action on the Respondent (See Table 1). The overwhelming majority of survivors/Complainants choose a path of no investigation (first three reasons total 82%). Occasionally a case is referred to HRM or the department for resolution when a resolution can be managed internally for a Complainant who wants to remain anonymous or when the offense does not rise to the level of Title IX but HRM or a department can provide supportive measures such that future harassment can be avoided.

There are 17 cases (9%) of the original 182 reports that remain open as of April 1, 2022 (See Table 2). Based on historical data, it is unlikely that Complainants in all 11 of the cases not being investigated will file Formal Complaints.

Table 3 shows the aggregated data for basis of complaint among the reports. In some reports, more than one type of power-based violence is alleged, so the total of these data points (193) exceeds the total number of cases (182).

As was the case in the previous biannual report, Sexual Assault (including Forcible Rape. Forcible Fondling, and Forcible Sodomy) was the most common reason (n = 60, 31%) for the report. As can be inferred from previous tables, in nearly all cases the Complainant did not file a Formal Report triggering an investigation. We ensure that all Complainants have information regarding supportive measures available to them, and of the options they have to hold the Respondents accountable for their alleged behavior.

Given the prevalence of cases identifying sexual assault as the basis for the complaint, the current status of those 60 cases are presented in Table 4. With few and rare exceptions when the safety of the community at large could be at risk, the Complainant in a case of sexual assault (or any Title IX behavior under the jurisdiction of LSU) makes the decision as to whether to file a Formal Complaint which triggers an investigation, attempt an Informal Resolution, or not move beyond the incident report. Our data indicate a minority of Complainants want to engage in the arduous task of moving through the Title IX process. Additionally, we can assume, based on data from national surveys, that a small percentage of students and employees who experience some type of sexual assault, harassment, or other forms of sexual misconduct file an incident report with the Title IX office. We know these are national problems.

Status of Sexual Assault Cases

Investigation Resolution

Several cases have completed Hearing Panels since the October report. These resolutions are not captured on the current spreadsheets but are important to report. In addition, the status of other cases have changed. Current data are reported below.

Since the October report, six open cases have been closed. Two went to a Hearing Panel and the Respondent was found responsible in both cases. One Respondent was expelled permanently from LSU and the other has sanctions that are pending. Two cases were closed after successful Informal Resolution. The remaining two were dismissed and closed. In one case the Complainant withdrew the complaint. In the other case, the Respondent was an employee who left the university.

Including the October and April reports, there are 11 cases that remain open. Two are in the phase of reviewing the investigative report with the expectation they will go to a Hearing Panel, two are in the Hearing Panel phase, five are under formal Investigation, and two are involved in ongoing Informal Resolution.
