- Graduate School (James Spencer): •
  - o Budget Hearings- now in session

- Carol developed recruiting plan starting Spring 2024
- How do we get a better package at LSU than any other school?
- 5-year program. 12 students per year
- 2024 Fees-spoke with Tommy Smith and he does not see any barriers to implementing the new state law regarding fees for graduate assistants.
- Will follow up with the administration to see if he could get a clear statement regarding saved fees for purposes of recruiting next year's graduate students.
- Calculated \$2,000 in savings for students.

Old Business:

- Guide to Graduate Faculty Status
  - The Graduate Council discussed Graduate Status Guidelines and decided to adopt the guidelines after dropping a paragraph that referred to the process of faculty losing Graduate Status "in some rare instances involving egregious actions." The Council found that because it is not involved in such investigations it would be inappropriate to advise/offer recommendations regarding such faculty's graduate status. It was recommended that the importance of clarifying the implications of Title IX investigations for a faculty member's graduate status to the Title IX office. "
