Based on the information presented and discussed, your organization, Chi Omega Sorority, accepts Responsibility for their actions, which constituted a violation of LSU's Code of Student Conduct, specifically:

10.2 Failure to Comply -- Responsible
10.2 Violating a Rule of the University -- Responsible

As a result of the incident that occurred on August 24, 2020, where Chi Omega Sorority members gathered with new members though no event should have taken place, your organization has submitted an Enhancement Plan. This will meet the requirements of the partnership process with Greek Life/Campus Life and Student Advocacy & Accountability:

Organization Warning

This accountability status will be effective December 2, 2020 through May 31, 2021. During this time, the organization may forfeit privileges as outlined below. The warning could be reflected on the Student Organization Scorecard.

With respect to the information listed above, the following additional sanctions/stipulations apply:

1. Each member will sign a COVID-19 guidelines contract for the Spring 2021 and Fall 2021 semesters based on LSU, PHC and Chi Omega rules. The contract and number of members who signed contracts will be sent to SAA by February 1, 2021 and April 30, 2021.
2. Members involved in the gatherings at Miller Dorm will have personnel meetings and will receive outcomes including delivering an informative presentation to the chapter on the importance of following COVID-19 guidelines. Presentation will be delivered by January 20, 2021. Confirmation of presentation will be sent to SAA by February 1, 2021.
3. Chi Omega will appoint class representatives to serve as COVID-19 compliance liaisons to routinely provide updates and reminders about the importance of complying with all COVID-19 guidelines as provided by PHC and LSU. Names of class representatives sent to SAA by February 1, 2021.

The following items will be completed by the deadline indicated and with verification of each item's completion submitted to Student Advocacy & Accountability using the [online reporting form](#) or via email to [REDACTED].

The Enhancement Plan and Accountability Outcome will be kept on file in Student Advocacy & Accountability within the Office of the Dean of Students. The Enhancement Plan will also be shared with all relevant LSU and headquarters staff.
