Dear Delta Chi,

On October 18, 2021, you met with Jonathan Sanders, who after a review of the information, has made the following determinations regarding your responsibility for the following charges from the LSU Code of Student Conduct:

10.2 Alcohol -- Not Responsible
10.2 Failure to Comply -- Responsible
10.2 Endangerment -- Not Responsible
10.2 Hazing -- Not Responsible
10.2 Coercive Behavior -- Not Responsible

Subsequently, you are assigned the following outcome:

Organization Warning

This accountability status will be effective November 12, 2021 through May 31, 2022. During this time, the organization may forfeit privileges as outlined below. The warning could be reflected on the Student Organization Scorecard.

With respect to the information listed above, the following additional sanctions/stipulations apply:

1. The Chapter will implement a weekly "F" Talk during the spring 2022 semester, to discuss common risk management topics once per week at regularly scheduled chapter meetings. The "F" will utilize the materials, including facilitator guides available on the Delta Chi Fraternity's <u>website</u>. The chapter will host at least 6 "F" Talks during the spring semester and will send conformation of completion to SAA by May 6th, 2022 with dates and topics covered.

2. The Chapter Executive Board will meet with Delta Chi Fraternity's Director of Member Safety to

discuss accountability and cooperating with both University Officials and Law Enforcement. Following this meeting, the Executive Board will relay the information discussed at their next regularly scheduled Chapter Meeting. Confirmation will be sent to SAA that this outcome has been completed by March 15, 2022 with the date for each of the meetings.

Confirmation outcomes have been completed can be submitted by filling out the <u>Organization Outcomes</u> <u>Report Form</u>.

The following rationale has been provided by the hearing officer / panel:

Based on my review of the information available for the case and my conversation with the chapter president for the fraternity, a preponderance of the information demonstrates that Delta Chi fraternity violated the Code of Student Conduct, specifically Failure to Comply. However, I was unable to reach a preponderance of the information standard for Alcohol, Hazing, Coercive Behavior, and Endangerment and have found you Not Responsible for these charges. The Delta Chi chapter president shared that members were present downstairs when LSUPD officers arrived and failed to answer the door during the multiple attempts by LSUPD officers to make contact with members and guest inside the house. As a result of the Failure to Comply violation, I have issued a Warning for the Delta Chi fraternity through May 31, 2022 and issued educational sanctions that will assist in learning from this incident and ensuring it does not occur again.

Per Section 6.0 of the Code of Student Conduct, you, on behalf of your organization, have the right to **accept** or **decline** this outcome. By accepting the outcome, your organization agrees to comply with the outcome and deadlines included in this letter, as well as accept responsibility for the organizations' actions in this case. To accept, you and your organization may simply work towards the deadlines for educational outcomes, there is no need to respond.

However, you, on behalf of your organization, may also decline the outcome in this letter and request that the case be reheard by a University Hearing Panel (UHP). In this instance, a UHP will issue a decision that will replace the outcome in this letter. Please refer to the <u>UHP Guide for Students</u> for more information on the hearing process. **You may request a UHP by completing following link** <u>UHP</u> <u>Request form</u> within three (3) business days of the date of this letter.

Your organization will be required to complete any conditions or activities as directed in this letter. Please understand that should the organization fail to complete any portion of this outcome, there may be additional outcomes or restrictions.
