To the members of Kappa Sigma Fraternity,

Based on the information reported by LSU Facilities Management, the Gamma chapter of Kappa Sigma Fraternity failed to comply with a current Enhancement Plan, which additionally constituted a violation of LSU's Code of Student Conduct. Specifically, not properly breaking down and disposing of debris in relation to the "Bahama Mama" party on April 22-23, 2016. As a result, your chapter has been found responsible for violating the following policies:

10.2.H. Failure to Comply: Defying the order or instruction of an authorized person on behalf of the University and/or any University policy, contract, mandate or rule;

10.2.O. Property Misuse: Intentional or reckless destruction, defacement or damage to University property or to the property of any individual or group; unauthorized entry or use of any property or facility;

10.2.W. Violating a Rule of the University: Violating, attempting to violate, or assisting in the violation of any contract, rule, policy, bylaw, and/or regulation of the University (specifically, PS-68).

As a result of the incident that occurred on April 22-23, 2016, where Kappa Sigma Fraternity failed to properly clean-up after a party that modified the grounds of your fraternity house and this also violated a current Enhancement Plan with LSU, the following will occur:

- As outlined in your Enhancement Plan, "If the Chapter fails to break down and dispose of all materials and debris following an event, in accordance with PM-68, it will forfeit the right to hold social events which require a Fraternity House Modification Permit for the semester immediately following the violation." Therefore, your chapter will forfeit the right to hold social events requiring such a permit during the Fall 2016 semester to conclude no earlier than December 31, 2016.
- Additionally, you should rectify this situation and have the debris removed according to PM-68. Please provide verification that this is complete to Student Advocacy & Accountability via email to rspencer@lsu.edu no later than May 31, 2016.
- For violating an agreed upon Enhancement Plan, that was originally proposed by the Chapter, the Letter of Reprimand will be extended through May 31, 2017.
