Course Description: The purpose of this course is to enable students to improve their understanding and analytical skills of international conflict and cooperation. From Thucydides to Kant, classical and modern thinkers attempted to develop concepts, frameworks and theories to offer solutions to the question of 'conflict' in international system in order to create an enduring peace based on "cooperation" among nations. In this sense, the emphasis of this course is on various theoretical frameworks not specifically current events. However, after an introduction of grand theories in International Relations, we will discuss several topics in International Conflict and Cooperation, such as alliances, deterrence, interdependence, crisis bargaining, as well as more specific theories, such as democratic peace. We will conclude our course with a discussion about the visions of future and the ethics of war.

Course Readings : There is no required textbook for this course. There are several research articles and book chapters provided through Moodle.

In addition to the assigned readings, students are expected to follow the current events in international politics; The New York Times Available online at <u>www.nyt.com</u>, The Economist Available online at <u>www.economist.com</u> and BBC News online at <u>http://news.bbc.co.uk/</u>
