#### **COURSE DESCRIPTION**

This course will introduce students to the litigation process within the American legal system. Emphasis will be placed on examinations of the federal system, the state system, and the fundamental principles of law associated within those systems. Students will study the organization of the courts and learn the roles of individuals that work within the systems. Specific areas of study will include [but are not limited to] jurisdiction and venue, the persons that are active within the system, civil litigation, the role of law enforcement within the criminal setting, specialized courts, appellate litigation, the use of technology in the courtroom, the use of social media within the systems, Louisiana politics, and other issues related to the legal system. Additionally, students will participate in courtroom observation and draft a document that relates to concepts in this course.

#### **COURSE OBJECTIVES**

Students will learn how judges, attorneys, witnesses, and litigation parties interact within our legal system and the significance of their interactions. Also, students will gain an understanding about the structures, organizations, and processes of court systems. Upon the completion of this course, the student will be able to describe the state and federal court system, understand issues related to litigation, identify the role of the persons in the litigation process, and have personal contact with individuals associated with the legal system either in a classroom setting and/or courtroom setting.

#### **COURSE REQUIREMENTS**

<u>ATTENDANCE: Students are expected to attend all classes.</u> Advanced arrangements should be made with the instructor should there be a need to miss class. A student missing class is responsible for all materials, notes, etc. disseminated in the missed class. Written documentation must be provided immediately upon return to support

an excused absence. An attendance record will be kept. Students are required to attend class, be prepared for classroom discussions, and participate in class. Students are responsible to know the LSU attendance policy.

Makeup examinations may vary in format and will be administered at the discretion of the instructor.

WRITTEN ANALYTICAL ASSIGNMENTS will be due prior to the taking of examinations. The due dates for uploading these assignments through the Moodle site are listed on the syllabus. It is your responsibility to keep track of these deadlines and complete the assignments on time. There are no grace periods for these assignments and submitting them after the deadline will result in a substantial reduction of points (if credit is earned). I recognize, however, there are legitimate reasons for missing a deadline.
