#### Introduction

The purpose of this course is to provide a broad overview to the political science profession and issues relating to professional success in the discipline. We will explore two major topics. First, we will focus considerable attention on the criteria for evaluation used in political science. What are the leading political science departments? Who are the leading scholars? What are the most important journals and scholarly presses? How do we know it when we see it? Second, we will discuss some of the practical issues relating to how one can succeed in the political science profession. How does one write a dissertation or thesis? How does one go about presenting a paper at a professional conference? How does one submit a paper to a scholarly journal? How does one publish a book? How does one go about obtaining employment as a political scientist?

#### **Course Requirements and Evaluation**

This class is offered on a pass-fail basis. Class participation and preparedness are major components of evaluation in graduate seminars. Each student will be evaluated on the basis of the quality of *informed* participation and contribution to seminar discussion. Specifically, each student is expected to have read and reflected upon all assigned readings before class, and should be prepared to discuss the reading assignments during the seminar meeting.

Class attendance is required.

## Readings

There are no required books for the seminar. However, in most weeks students will be given a small set of readings to be read for the seminar. Assigned readings are found in the accompanying course outline. Required readings are denoted with an asterisk (\*). Other readings may be read based on your own interests and inclinations. Readings will be made available to students electronically (as .pdf files) on the course Moodle page.

#### About the Instructor

James C. Garand (Ph.D., University of Kentucky, 1984) is the Emogene Pliner Distinguished Professor of Political Science at Louisiana State University.

Professor Garand has teaching and research interests in the fields of legislative politics, electoral politics, public opinion, public policy, state politics, racial and ethnic politics, domestic political economy, and research methodology and statistics. His research on a wide range of topics in American politics has been published in numerous journals, including the American Political Science Review, American Journal of Political Science, Journal of Politics, British Journal of Political Science, Political Research Quarterly, Western Political Quarterly, Comparative Political Studies, Legislative Studies Quarterly, PS: Political Science and Politics, American Politics Research, American Politics Quarterly, State Politics and Policy Quarterly, Public Choice, Social Science Quarterly, and Electoral Studies, among others. His coedited book, Before the Vote: Forecasting American National Elections, was published by Sage Publications in 2000. His current research agenda includes numerous projects relating to the study of American politics.

Professor Garand received the 2006 LSU Distinguished Research Master Award in recognition of outstanding faculty accomplishments in research and scholarship. In 2009 he was recognized as an LSU "Rainmaker," an award given by the LSU Office of Research and Economic Development (ORED) for national and international recognition "for innovative research and creative scholarship." He served as President of the Southern Political Science Association in 2004, and he is also former president of the State Politics Section of the American Political Science Association. He served as Vice-President and Program Chair in 2001 for the Southern Political Science Association. Professor Garand is former editor of the *American Politics Quarterly*, one of the leading subfield journals in American politics. He currently serves on the editorial boards of the *PS: Political Science and Politics, American Politics Research, Journal of Political Marketing*, and *Ralph Bunche Journal of Public Affairs*, and he is a former member of the editorial boards of the *American Journal of Political Science, Journal of Politics, State Politics and Policy*, and *Legislative Studies Quarterly*. He also serves as a member of the International Advisory Board of the *Online Portal for Social Science Education in Methodology* (OPOSSEM).

Professor Garand has received numerous faculty awards. In 1997 Professor Garand received the LSU Alumni Association Distinguished Faculty Award in recognition of sustained excellence in teaching, research, and service. In 2012 he received the Tiger Athletic Foundation Undergraduate Teaching Award recognizing excellence in teaching in the LSU Honors College. In 2001 he received the LSU Foundation Distinguished Faculty Award in recognition of his excellence in graduate teaching, and he is the 1990 recipient of the university-wide Student Government Association Teaching Excellence Award for undergraduate teaching. He is also a recipient of the Alpha Lambda Delta Freshman Honor Society certificate of recognition for superior instruction of freshman students during the Fall 2000 semester.
