## **POLI 7970: Seminar in Comparative Politics**

The course is designed to provide graduate students with a broad overview of the field of comparative politics. We will begin with readings which focus on the field of comparative politics and its relationship to the broader discipline. The remainder of the readings will present seminal works and examples of the diverse theoretical and empirical approaches which have been employed in this field. Some readings are selected because they are classics in the field. Others are insightful reviews of literature. And some readings are assigned because they provide clear illustrations of a particular theoretical argument or methodological approach. While the reading list for the course is long, it is only a sample of the voluminous literature on this topic, and students are encouraged to use these readings as the staring point for their own exploration of the literature.

LSU divides up Comparative Politics according to the expertise of our faculty who offer graduate courses on Comparative Institutions, Comparative Political Economy, Comparative Political Behavior, and State and Society. I will try not to overlap too much with these courses, and focus instead on as broad a survey of the field as possible. Some important works are omitted from this list because you will be required to read them in the other graduate seminars.

#### **Requirements:**

The course is a seminar, and students are expected to do all required readings before class, and to come to class prepared to discuss these readings. It is helpful if students write brief summaries of all the readings assigned each week. In order to facilitate discussion, students are required to post one discussion question about each required reading on the course moodle site by midnight on the Thursday before class. Four short writing assignments will require students to synthesize material presented in the class and to analyze patterns in the evolution of the literature. There will also be a take home midterm and final exam with questions similar to those asked on the Comparative Politics comprehensive exam. Grades will be based on these requirements according the following formula:

- Participation and Discussion Questions posted on Moodle: 20% total
- Midterm Exam essay: 20% total
- 4 Short papers: 40% total (10% percent each)
- Final exam essay: 20%

## Theory and Methodology I

Select a recent article on Comparative Politics that uses a qualitative research design. (Seek instructor approval of your selection before you begin.) Write up an evaluation of this article. Discuss the article in terms of the theoretical approach and the methodology employed. Discuss

whether and how this question could be addressed using a quantitative rather than qualitatiative approach. Be sure to accurately describe the article, and offer a critical assessment of the argument and evidence. (Critical meaning a thoughtful evaluation, not necessarily a negative one.)

Data Report: submit a data report of 3-4 double-spaced pages in length that describes one of the following data sets in the field of comparative politics.

- <u>Survey Data Sets</u>: The World Values Survey, Latin American Public Opinion Project (LAPOP), the Arab Barometer, and the Comparative Study of Electoral Systems
- Institutional Data Sets: The World Bank's Database of Political Institutions, Matt Golder's Democratic Electoral Systems Around the World, the Quality of Government (QOG) Institute, the Comparative Constitutions Project, and the Autocratic Regimes Data
- <u>Parties and Elections Data Sets</u>: Dawn Brancati's Global Elections Database, Yale's National Elections Across Democracy and Autocracy (NELDA), the Comparative Manifesto Project, and the Party Government Data Set (PGDS)

Social and Conflict Data Sets: the Cross-Cutting Cleavages Data Set, the Minorities at Risk (MAR) Project, the Human Rights Data (CIRI) Project, and the Armed Conflict Data Set (UCDP) This report should include the following:

(1) a general description of the data set and its empirical scope,

(2) examples of peer-reviewed research manuscripts that have recently drawn on this data set,

(3) a technical description of how to download, open, and begin analyzing the data, and

(4) specific instructions for how to calculate a conceptual variable of interest utilizing this data (such as "electoral volatility" or "economic performance" or "ideological polarization") (With thanks to Josh Potter who first assigned this data report paper to LSU students. Though I only make you write one of these <sup>(C)</sup>)
