

# Spanish Course Placement Guidance: Heritage Speaker vs. Native Speaker of Spanish

When scheduling students in Spanish classes, please find out whether they are **heritage** speakers or **native** speakers of Spanish by asking whether they completed high school in the US or a country where Spanish is the official language. **Spanish heritage speakers** have different options than **native speakers**.

## Heritage speakers are...

• Students who **completed high school in the US** and had exposure to Spanish in their home or community.

## Keep in mind:

- These students may be born in a country where Spanish is the official language **or** born in the US.
- They may have attended some years of school in a country where Spanish is the official language and some in the US.

Heritage speakers with intermediate fluency have the option to take **Span 2155 Spanish Language and Culture for Heritage Speakers** (Contact <u>spanishua@lsu.edu</u> for permission to enroll in section 3 for fall 2025). Upon completion of this core course in the Spanish minor, credit can be awarded for Span 1101, 1102, 2101, 2102 to meet a foreign language requirement. Heritage speakers may also take the Spanish placement exam or see the Spanish Undergraduate Advisor (<u>spanishua@lsu.edu</u>) for placement assistance or information about the Spanish major or minor.

## Native speakers are...

- Students who completed high school in a country where Spanish is the official language. This includes:
  - International students who completed high school in a Spanish speaking country.
  - Puerto Rican students who completed high school in Puerto Rico.
  - US resident or citizen students who completed high school in a Spanish speaking country.

Native speakers who wish to take Spanish may contact the Spanish Undergraduate Advisor (spanishua@lsu.edu) to register for 3000/4000-level classes and for information about the Spanish major or minor. Students who fit this definition of "native" speaker may **not** take the Spanish placement exam and will **not** receive foreign language credit for Spanish lower-division courses (1000 or 2000-level). See the LSU General Catalog for options to fulfill a Foreign Language Requirement for a specific Degree Program.

## Spanish Placement Exam

All students **other than native speakers** (as defined above) can request to take a placement test through their major college or during orientation. The <u>placement exam form</u> requires a signature from the college and the Dept. of World Languages, Literatures, & Cultures (<u>worldlang@lsu.edu</u>). Instructions are on the form and testing should take place at the LSU testing center before the deadline to drop and add courses.

## Departmental placement procedures:

**Heritage speakers** who self-place or are placed into Spanish 1101, 1102, 2101, or 2102 by an advisor outside of the Department of World Languages will be screened through a class survey and interview with a Spanish Program Administrator. Through this process, heritage speakers will be placed into the appropriate course based on their Spanish proficiency.
